



## **LICENSE AGREEMENT TO USE COPYRIGHT-PROTECTED MATERIAL**

WHEREAS the Licensor owns all proprietary rights in and to the copyrighted works in the literary works, drama, film, video footage, photographs, graphic images including visual artworks, musical and other sound recordings, and computer software, etc. specifically identified in the Annex hereto (the “Licensed Material”).

It is hereby agreed that:

1. The Licensor hereby grants to the SSSWF, its successors and assigns, the non-exclusive worldwide license to use, copy, edit, merge, modify, recast, transform, display and to transmit, publish, distribute, etc. the Licensed Material, and to prepare any derivative works therefrom, for any of its educational, spiritual, service or other activities, whether online or onsite, which may be electronically transmitted and/or uploaded / displayed on the Internet or otherwise published / distributed in the public domain in an unrestricted geographic area. In making this grant, the Licensor retains the title and ownership in the Licensed Material.
2. The license is hereby granted as a gift, free-of-charge and royalty-free to the SSSWF, which is a not-for-profit spiritual and service organization.
3. The SSSWF shall be the sole owner of the derivative works created by it in connection with this license and all proprietary rights thereto, but such ownership shall not include ownership of the copyright in the Licensed Material or any other rights to the Licensed Material not granted by this License Agreement.

4. The Licensor shall not have control over and right to approve the quality and use of the derivative works created by the SSSWF. In modifying, recasting, transforming, etc. the Licensed Material and creating any derivative works therefrom, the SSSWF shall have regard to the Licensor's standards in relation to the Licensed Material.
5. The term of this License Agreement shall commence on the Effective Date and shall continue for a fixed term of ten (10) years. It shall be automatically extended for further terms of ten (10) years unless terminated in writing by either party for any reason upon a minimum of ninety (90) days' notice prior to the expiration of the term.
6. The termination of this License Agreement shall not relieve the parties of rights and obligations accruing prior to such termination. Where the Licensed Material has been edited, merged, modified, recast, transformed, adapted, etc. and any derivative works are prepared therefrom, and the latter have been electronically transmitted and/or uploaded / displayed on the Internet or otherwise displayed, published, distributed, etc. in the public domain as aforesaid, SSSWF's rights in respect thereof shall survive the termination of this License Agreement.
7. This License Agreement shall be binding upon and inure to the benefit of the parties and their respective legal representatives, successors, and permitted assigns.
8. This License Agreement constitutes the entire agreement and the understanding of the Licensor and the SSSWF with respect to the subject matter hereof and supersede all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.
9. No modification or claimed waiver of any provision of this License Agreement shall be valid except by written amendment signed by authorized representatives of the parties.
10. The validity and interpretation of this License Agreement will be governed by the laws applicable in the state of California, USA, whose courts shall have exclusive jurisdiction with regard to any dispute or claim arising under this License Agreement.
