- 4. The Licensor shall not have control over and right to approve the quality and use of the derivative works created by the SSSWF. In modifying, recasting, transforming, etc. the Licensed Material and creating any derivative works therefrom, the SSSWF shall have regard to the Licensor's standards in relation to the Licensed Material.
- 5. The term of this License Agreement shall commence on the Effective Date and shall continue for a fixed term of ten (10) years. It shall be automatically extended for further terms of ten (10) years unless terminated in writing by either party for any reason upon a minimum of ninety (90) days' notice prior to the expiration of the term.
- 6. The termination of this License Agreement shall not relieve the parties of rights and obligations accruing prior to such termination. Where the Licensed Material has been edited, merged, modified, recast, transformed, adapted, etc. and any derivative works are prepared therefrom, and the latter have been electronically transmitted and/or uploaded / displayed on the Internet or otherwise displayed, published, distributed, etc. in the public domain as aforesaid, SSSWF's rights in respect thereof shall survive the termination of this License Agreement.
- 7. This License Agreement shall be binding upon and inure to the benefit of the parties and their respective legal representatives, successors, and permitted assigns.
- 8. This License Agreement constitutes the entire agreement and the understanding of the Licensor and the SSSWF with respect to the subject matter hereof and supersede all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.
- 9. No modification or claimed waiver of any provision of this License Agreement shall be valid except by written amendment signed by authorized representatives of the parties.
- 10. The validity and interpretation of this License Agreement will be governed by the laws applicable in the state of California, USA, whose courts shall have exclusive jurisdiction with regard to any dispute or claim arising under this License Agreement.
